Terms and Agreements of Student Enrollment

Tuition

1. Tuition must be paid by the due date unless payments will be subject to a late fee of \$50
2. Refunds must be submitted in writing, no exceptions. Before the beginning of the first class, 90% of payment will be refundable. After the first class and before the beginning of the second class, 70% of payment will be refundable. After the second class and before the beginning of the third class, 50% of payment will be refundable. After the third class, there is no refund.

Payment

1. Unpaid and overdue accounts will be referred to a collection agency and reported to a credit bureau, and you will be responsible for all fees associated with the collection agency.
2. Any checks returned with Non-Sufficient Funds (NSF) will be charged a NSF fee of \$50

Attendance

1. Smart Coding School does not provide childcare services. Please be prompt in picking up your child. A fee of \$10 per child will be assessed for every 15 minutes not picked up after the student's last class.
2. Parents are not allowed to be in the classroom. Only exception can be made if parents are the students who are enrolled in the same class with their child in smart coding school as well.
3. Make-up for classes missed can be rearranged if possible but no guarantee.

Academic Standards

1. I understand that although the goal is to improve academic performance, Smart Coding School cannot guarantee any results regarding academic performance.
